1993-present Research: I have served as principal investigator, co-investigator, consultant, project coordinator, research associate and research assistant on federally funded or privately funded research projects. I received two predoctorate research fellowships, one from the National Institutes of Health/National Institute on Aging (NIH/NIA) and the second from The University of Illinois at Chicago, Graduate College.

Post doctorate funding were received from (a) NIH/National Institute of Nursing Research (NINR) for a career development award to develop an instrument to measure trust in African American caregivers of older adults and to determine the relationships among trust in healthcare providers, religiosity, and personal characteristics on end-of-life decision; (b) NIH/NINR to study the feasibility of a health education program for dementia caregivers; (c) NIH/National Institute on Aging(NIA) to test the efficacy of an education program for African American dementia caregivers on end-of-life decision-making in a community-based setting. I have published more than 20 manuscripts in peerreviewed journals. In addition, I co-authored one published one book chapter. My ongoing research interests are African American family caregiving of relatives with dementia and advance care planning (end-of-life treatment decisions).

This center was developed to refer patients discharged from the emergency room to community based health care facilities for follow-up medical care. Four community-based health care agencies contracted with Cook County Hospital to provide the follow-up services. To date, the center remains open and has expanded contracts with other community agencies.
- b). Home Care Referral Tracking System implemented through Fantus Clinics. This system was developed to coordinate referral services for patients

discharged from the hospital who were in need of home bound nursing and social services. Follow-up of home care services rendered were tracked through return appointments at the Fantus Clinics. The program continued

from 1985 to the middle 1990s.

- c). AIDS Treatment Evaluation Unit implemented through Department of Medicine from 1986 through 1990. This specialized unit was established to serve the needs of patients diagnosed with Acquired Immune Deficiency Syndrome (AIDS). The unit was constructed for 10 patients and served as a model for a larger hospital unit that was later developed to serve up to 100 patients evaluated for or diagnosed with the disease.
- d). Hospital-wide 23 Hour Observation Unit implemented through Hospital Administration in 1987. This program was designed to serve patients admitted to the emergency room in need of extended observation by physicians but not formally admitted to the hospital. The observation units were built to accommodate eligible patients for a maximum of 23 hours prior to final medical disposition for hospitalization. To date, the program continues in selected hospital departments.

1978-1985: Nurse practitioner and clinical specialist in the General Medicine Clinic and nurse manager of Family Practice Clinic. Functioned as an adult nurse practitioner, managing patients with hypertension, congestive hear failure and arthritis. As a clinical specialist developed and implemented protocols for patients enrolled in the Obesity and Stop-Smoking Clinics. Trained nursing staff to teach in the "Stop Smoking" Clinics. Received certificates from the American Cancer Society, Chicago Lung Association, Cook County Hospital-nursing division, and Illinois Nurses Association for programs such as stop smoking, patient discharge planning, quality assurance, basic program management and budget strategies in nursing service. Supervised nursing staff assigned to the Family Practice Clinic.

Served as staff and charge nurse on medical and psychiatric units. Supervised nursing staff at community based hospital. As a public health and visiting nurse, home bound nursing care was managed for predominately adult patients and families. Health promotion and disease management were intricate components of the services provided.
